Participation in the Contra Costa County Honor Band is a privilege and a responsibility. This Participation Agreement was created for 2 primary reasons: (1) to clearly explain the expectations that are required in order for a student to serve as a member of the County Honor Band, and (2) so that no individual would lose the opportunity to participate because of another student's inability to fulfill the obligations agreed to upon their selection. Please read and sign the agreement prior to the first reading rehearsal. Signing this contract indicates that the student and parent understand and agree to abide by the policies and procedures for the Contra Costa County Honor Band listed below:

- Selected students must participate in all rehearsals and performances as listed below. Failure to participate in any rehearsal, part of a rehearsal, or demonstrate tardiness may result in dismissal of that student from the ensemble. This agreement includes any school or educational function, standardized test or competition that is occurring simultaneously to the Honor Band, family obligations, illness and even family/personal emergencies.
- This form must be completed and returned to the Honor Band President along with the \$20 participation fee prior to the student participating in the reading rehearsal on Dec. 7, 2024 at 9am.
- All District and Individual School policies are in effect during rehearsals and performances. This also includes the specific school rules of the Administration of the Host School.
- Dinner during the Friday rehearsal will be offered on the campus of the host school. Students will not be allowed to leave campus for dinner or any other reason. Lunch on the Saturday rehearsal is up to the student. They may choose to bring their own food or go off campus.
